

## IOWA HORSE COUNCIL VOLUNTEER AGREEMENT - WAIVER AND RELEASE OF LIABILITY

I hereby volunteer at the lowa Horse Fair at my own risk and subject to all the rules and regulations of the lowa Horse Fair. I have read the information regarding the event and agree to follow the guidelines as set forth by the lowa Horse Council.

- 1. It is the responsibility of the Volunteer (Parent or Guardian if a Minor) to carry full and complete insurance coverage on him/herself.
- 2. Volunteer (Parent or Guardian if a Minor) agrees to assume all risks involved in or rising from Volunteer's use or presence upon the Iowa State Fairgrounds property and facilities during the Iowa Horse Fair including but not limited to, risk of death, bodily injury, property damage, falls, kicks, bites, collisions with vehicles, horses or stationary objects, fire or explosion, the unavailability of emergency medical care, or the negligence or deliberate act of another person.
- 3. Volunteer (Parent or Guardian if a Minor) agrees to hold the lowa Horse Council, its directors and all individual members thereof, the lowa State Fair management or employees or any other persons involved in the Horse Fair management completely harmless and not liable, and release them from all liability whatsoever, and agree not to sue them on account of/or in connection with any claims, caused of action, injuries, damages, costs or expenses arising out of Volunteer's use and/or presence upon the lowa State Fairgrounds property and facilities during the Iowa Horse Fair, including and without limitation to those based on death, bodily injury, property damage, including consequential damages.
- 4. Volunteer (Parent or Guardian if a Minor) agrees to indemnify and defend the lowa Horse Council against and hold harmless from any and all claims, causes of action, damages, judgments, cost of expenses, including attorney fees, which in any way arise from the Volunteer's use of/or presence upon the lowa State Fairgrounds property and facilities during the lowa Horse Fair.
- 5. Volunteer agrees to abide by all the Iowa Horse Fair Rules and Regulations.
- 6. This contract is non-assignable and non-transferable and is made and entered into the State of Iowa and shall be enforced and interpreted under the laws of the state. When the Volunteer (Parent or Guardian if a Minor) signed this contract, it will then be binding on all parties, subject to the above terms and conditions.
- 7. By signing this contract, I agree that I am responsible for my own safety. I understand that horses can be excitable, unpredictable and difficult to control at times, and that accidents may happen when working with horses.
