**CHECK-IN LOCATION:** Rock Island parking lot, directly south of the fairgrounds Gate 8

Your cooperation will help ensure a smooth check-in process and protect the health of all participants' horses

**Horses may begin arrival as soon as 9am Friday March 26<sup>th</sup> 2021**

**Any earlier arrivals MUST be approved with the Barn Manager and Check -In coordinator by March 1st**

- o ALL horses will be directed to the East entrance of the Rock Island parking lot prior entrance to the fairgrounds. Please see the enclosed map and traffic flow instructions.
- o In the Rock Island parking lot, the Fair Vet will visually inspect each horse and validate the Health/Coggins papers as required by Iowa State Law.

**Please have the Health Certificate completed within 30 days of the 2021 IA Horse Fair dates (4/3-4/5)**

**For out-of-state horses, please also have your negative Coggins certificate available for inspection**

- ☐ Please have your papers indicate "Iowa State Fairgrounds/ Des Moines, IA" as your destination address.
- ☐ If you arrive without a valid Health Certificate, the Fair Vet can issue this document onsite for \$25 / horse as time permits. (Lack of required health papers will delay your entry to Fairgrounds)
- ☐ The vet will keep your validated health papers in the Horse Barn office

- ☐ After inspection of each horse and validation of required paperwork, each vehicle pulling a loaded trailer will receive an unloading pass to hang from the rearview mirror. This will be required in order to unload horses inside the fairgrounds.
  - o Livestock Traffic Control/Security will notify staff at Rock Island/Gate 8 when there is space available around the horse barn for a trailer to be released to the barn for unloading. (Anyone entering from other fairground gates will be directed to Rock Island parking lot for processing and an unloading pass)
- ☐ Upon parking at the barn, volunteers will be available to assist with unloading of equipment and delivery to assigned stalls.
- ☐ After unloading, trailers will be directed to trailer parking locations (if needed)

**\*\*\*Refusal to abide by these procedures will result in the revocation of the use of your horse(s) in the 2021 Iowa Horse Fair \*\*\***

**After unloading, please remove your vehicle and trailer from the around the barn as soon as possible to make room for the next person in line.**

**Service Stalls:** Service stalls are available again this year for those who wish to provide fee-based services to horses at the fair. Be sure to check them out! Information will be posted around the barn and in the fair program regarding services being offered

**Friday night:** 5:30 pm – Cattle Barn Arena – Barn Meeting –

\*\*\*This meeting is highly recommended to attend as this is where any questions may be asked, Parade of Breed Group assignments for each division (in-hand, riding, driving) are delivered, and door prizes will be awarded!!!!

**Avenue of Breeds:** Parade of Breeds – Noon both Saturday/ Sunday - Pavillion

The horse selected for Breed representation should be stalled according to the stall front display. (Relocating a Breed representative stall is discouraged unless absolutely necessary (**approval from Barn Manager required**))

**\*\*Avenue of Breeds horses are expected to be clean and show-ready at all times as they are intentionally ‘on display’ for the weekend. Plan accordingly as the wash bays for the horses are not equipped with hot water. In the event of unfavorable weather, the wash bays may be shut off completely. Stalls are to be clean and area in front of stalls should remain clean and clear as well. (Failure to do so may result in denial of subsequent year participation)**

Horses in the ‘showcase’ of the Parade of Breeds (held on Saturday and Sunday in the Pavillion) are expected to be clean, show ready, and under control at all times.

**\*\*Removal from the Avenue of Breeds and/or Parade of Breeds is at the discretion of Barn Manager and/or Breed Coordinator\*\***

Handlers / Riders for the Parade of Breeds are also expected to be in clean presentable attire as if presenting under a judge.

\*\*\*Authentic attire to showcase your breed is HIGHLY ENCOURAGED\*\*\*

**“Best In Show”-** will be back again for 2020 – crowd participation by voting for Parade of Breed presentations in all 3 divisions (In-Hand, Riding, and Driving)

**CHECK OUT** – All horses except those in the Avenue of Breeds may leave the horse fair at their discretion. However, the Avenue of Breed horses are expected to remain stalled until the end of the horse fair: **5pm Sunday.**

## 2021 Iowa Horse Fair HORSE BARN INFORMATION

1. Horse or tack stalls are available for \$60/weekend, payable in advance. This fee must be paid before stalls are occupied. Two bags of bedding per horse stall fee will be furnished & additional bags will be available for purchase at the Horse Barn Office. **NO OUTSIDE BEDDING IS ALLOWED.**
2. Horses may arrive anytime after 9:00 AM on Friday. The barn office will close at 8:00 PM on Friday and will re-open approximately 7:00 a.m. on Saturday. We ask that you make arrangements with the Barn Manager for any earlier arrival times as staff and Vet availability must be considered before approval to arrive early.
3. Horses must be in their stalls by the start of the Horse Fair on Saturday (8:00 a.m.) with the exception of Cowgirl Queen participants who may check in by noon on Saturday at the latest.
4. **A STALL DECORATING CONTEST WILL BE HELD!** Please have stall decorations and horses ready for viewing by 8:00 am Saturday. Stall judging will take place sometime on Saturday during the Horse Fair. **Horses in the Avenue of Breeds may not depart until the horse fair hours are over.** We suggest you have a person with your horses during the Horse Fair open hours so any questions may be answered.
5. Stall areas are to be kept presentable. Failure to do so could result in a 1 year suspension from participation at the event. You may put promotional materials designated for your breed group on any stall, EXCEPT on Avenue of Breeds stall (as decorations are provided) **NO TABLES, EXTRA HAY, OR ROPED OFF AREAS WILL BE ALLOWED IN THE BARN AISLES FOR SAFETY REASONS.** An extra stall can be purchased to use for promotional materials, fee, and tack. There are flyer holders available that attach to the stall, just ask the Barn Manager if you need one.
6. **Health papers will be checked for every horse before entering the fairgrounds. The staging area for checking papers and having the fair vet observe the horses entering the horse fair will be done in the Rock Island parking lot which is directly south of the fairgrounds on Dean Avenue.** Health certificates (within 30 days) will be required for all horses. Out-of-state horses must also provide a negative Coggins test (within 12 months). Be sure to have health papers ready to present in the staging area to minimize wait time to enter the fairgrounds. Horses showing symptoms of communicable illness will not be admitted onto the fairgrounds. If you forget to bring a health certificate, the fair vet will do an exam and provide a certification for \$25/horse. However, participants who require this service may be moved to a secondary staging area and provided service as time permits. This could result in a substantial wait time during busy check-in times. Once you are cleared for entry and directed to your unloading spot by the horse barn, quickly unload your horse(s) and equipment and clear your vehicle from the area. **Trailers may not be parked around the barn area except for loading and unloading.**
7. Each stall owner will receive **one wrist band** (good for the entire weekend) for entry to the Pavilion/Cattle barn & and Tradeshow. This wrist band will be included in the participation packet that is distributed at check in. Any additional wristbands can be purchased at the Barn office.
8. Each breed representative must have all persons bringing horses to the Fair sign a liability/disclaimer form, releasing the IHC/IHF from all liability. Please copy as needed for multiple members of breed groups. We request that you get the required signatures and either return the forms in advance or present the completed forms at Check-in.

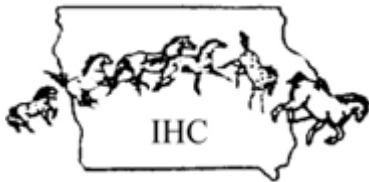
**PLAN TO ATTEND THE ALL-BARN MEETING ON FRIDAY EVENING (APPROXIMATELY 5:30) BY THE CATTLE BARN ARENA. THIS IS THE TIME TO HAVE YOUR QUESTIONS/CONCERNS ADDRESSED PLUS DOOR PRIZES!!**

9. Security will be furnished in the Horse Barn. Security will begin at 12 noon on Friday and end at 5:30 pm on Sunday. We will have a veterinarian on call at all times. **The IHC/IHF will not be responsible for any loss or damage to horses or property.**
10. A stall emergency form must be completed for each horse/ stall combination to include a contact person's name and phone number so that they can be reached in case of an emergency. Veterinarians are legally unable to treat a horse without the permission of the owner or their representative.
11. We ask that you leave dogs at home, but if you must bring one, they must be kept in a stall or on a leash. **NO DOGS ARE ALLOWED IN THE TRADESHOW OR PAVILION** except for a service dog.

**BARN RULES will be enforced by Fairgrounds Security**

**NO SMOKING IN THE BARN --- NO ALCOHOL IN THE BARN --- NO RIDING IN THE BARN -- NO SLEEPING IN THE BARN**

**NO MOTORIZED VEHICLES IN THE BARN (Except for those authorized)**

### Liability Release

*Please read carefully*

I wish to participate in the 20\_\_\_\_ Iowa Horse Fair to be held \_\_\_\_\_, 20\_\_\_\_, with my horse or another person's horse which I will be responsible for during the course of the Horse Fair. I hereby participate in the Iowa Horse Fair at my own risk and subject to all the rules and regulations of the Iowa Horse Fair. I further agree that if any damage is occasioned, or loss occurs to the horse exhibited, to any vehicle, or other article with I may send with such horses that I will make no claim against the Iowa Horse Council or any of its officials. I have read the information regarding the event and agree to follow the guidelines as set forth by the Iowa Horse Council.

1. It is the responsibility of the Rider (Parent or Guardian if a Minor) to carry full and complete insurance coverage on said horse, personal property, and himself.
2. Rider (Parent or Guardian if a Minor) agrees to assume all risks involved in or rising from Rider's use or presence upon the Iowa State Fairgrounds property and facilities during the Iowa Horse Fair including but not limited to, risk of death, bodily injury, property damage, falls, kicks, bites, collisions with vehicles, horses or stationary objects, fire or explosion, the unavailability of emergency medical care, or the negligence or deliberate act of another person.
3. Rider (Parent or Guardian if a Minor) agrees to hold the Iowa Horse Council, its directors and all individual members thereof, the Iowa State Fair management or employees or any other persons involved in the Horse Fair management completely harmless and not liable, and release them from all liability whatsoever, and agree not to sue them on account of or in connection with any claims, caused of action, injuries, damages, costs or expenses arising out of Rider's use and/or presence upon the Iowa State Fairgrounds property and facilities during the Iowa Horse Fair, including and without limitation to those based on death, bodily injury, property damage, including consequential damages.
4. Rider (Parent or Guardian if a Minor) agrees to indemnify and defend the Iowa Horse Council against and hold harmless from any and all claims, causes of action, damages, judgments, cost of expenses, including attorney fees, which in any way arise from the Riders use of or presence upon the Iowa State Fairgrounds property and facilities during the Iowa Horse Fair.
5. Rider agrees to abide by all of the Iowa Horse Fair Rules and Regulations.
6. The horses shall be free from infection, contagious or transmissible disease(s). The Iowa Horse Council reserves the right to refuse the horse if not in proper health or is deemed dangerous or undesirable.

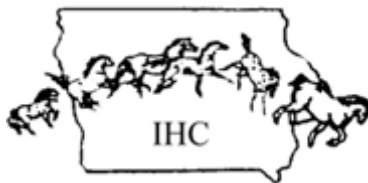
